## What is the E-Rate program?

The Schools and Libraries Program, more commonly known as E-Rate, is a federally funded program that helps schools and libraries get access to affordable managed internal connections and internet access. Administered by the Universal Service Administrative Company (USAC) under the direction of the FCC, E-Rate can help your institution get discounts of 20% to 90% on eligible services.

## Who is eligible for E-Rate funding?

Public and private K-12 schools and nonprofit public libraries are eligible for E-Rate discounts. Groups of schools and libraries (such as consortia, districts and systems) are also eligible. Not sure if your institution qualifies? Full eligibility requirements are available on the E-Rate website.

# What services qualify for E-Rate funding?

You can request E-Rate funding under two categories: Category One includes managed internal connections services and internet access. It typically gets funding priority over Category Two services. Category Two includes internal connections, basic maintenance and managed internal broadband services. A full list of services eligible for E-Rate discounts is updated and published each year by USAC.
